In any case, you can ask for the revocation of the given consent, if this was the legal basis on which the processing lays down or exercise your rights of:

- Access: the data subject has the right to know whether the controller processes his personal data and, if so, has the right to access this data, as well as to obtain information about the processing carried out.

- Rectification: It is linked to the inaccuracy of the personal data being processed. The data subject has the right to rectify the inaccurate personal data or to be completed.

- Deletion: the right to obtain the deletion of their personal data (“right to be forgotten”), when these are no longer necessary for the purpose for which they were collected, the consent on which the processing was based is revoked, the data subject opposes to the processing, the data have been treated illegally, have to be deleted to comply with a legal obligation or have

been obtained in relation to the offer of services of the information society aimed at minors.

- Limitation of processing: it is the right of the data subject to mark the personal data retained in order to limit their processing in the future. The limitation of processing means that, at the request of the person concerned, the marked personal data will no longer be processed.

- Opposition: the data subject has the right to object to the processing of the personal data when the objection comes from a certain specific cases when related to data subject personal situation.

- Data portability: the data subject has the right to receive the personal data provided to the controller in a structured, commonly used and mechanically readable format, if it is based on consent or a contract, the processing is carried out by automated means.

- Unless the subject of automated individual decisions: the data subject has the right of not being subject of a decision based on the automated processing of personal data, including data profiling which can produce direct legal effects or adverse effects on the data subject.
